




Title 32, Article 1 Special District Notice of Return to Active Status


WHEREAS, pursuant to § 32-1-104(3)(b), C.R.S., the District has determined that it shall return to active status.

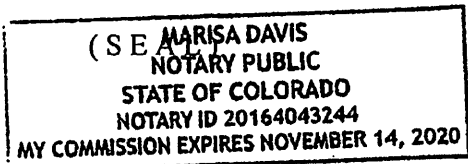


